

# **TERMS OF REFERENCE FOR MEDICAL INSURANCE 2026**

### Background

Right To Play (RTP) is a global children's organization that protects, educates and empowers children to rise above adversity. This call for proposal is open on equal terms to all insurance companies registered in Rwanda.

# The proposal should include the following:


## A. Technical proposal

- 1. Registration certificate from RDB
- 2. Company profile showing the company background
- 3. Audited financial statement for the last 2 years (2023 & 2024)
- 4. Proof of insurance services offered to 4 institutions including at least two NGO and one Government institution.
- 5. Confirmation of reinsurance cover & Proof
- 6. Nationwide coverage/all health facilities (Public and Private including Pharmacies)
- 7. Valid RRA tax clearance certificate
- 8. Valid RSSB certificate
- 9. Flexibility within limits benefits and within the overall cover.
- 10. Procedures for reimbursement of premium paid in case of staff departure or replacement with new staff hired.

## B. Financial proposal

The Medical Insurance coverage should be first category and should indicate the detailed benefits with the following conditions:

- ✓ Administration fees per person
- ✓ Premium Breakdown
- ✓ Detailed list of other benefits and sum assured including worldwide Benefits if applicable
